

AND WHEREAS the Settler has handed over the said sum of Rs. 1,000/- (Rupees One Thousand) only to the Trustees to be held by them upon the Trust with the power, agreement and subject to the provision here-in-after contained and declared in these presents concerning the same;

AND WHEREAS the Trustees do hereby confirm and acknowledge the receipt of the aforesaid sum of Rs. 1,000/- (Rupees One Thousand) only for the purpose of aforesaid;

NOW THIS INDENTURE WITNESSETH AS FOLLOWS

1. The Settler has, before the execution of these presents, transferred and delivered and the Settler do hereby confirm such transfer and delivery upto the Trustees of the said sum of Rs. 1,000/- (Rupees One Thousand) only and all the right, title and interest there in and the Trustees hereby acknowledge the receipt thereof.
2. The Trustees shall stand possessed of the said sum of Rs. 1,000/- (Rupees One Thousand) only and the investments for the time being representing the same and all future donations and contributions to this Trust and the





dividends and all other income and profits thereof and other investments thereof here-in-after referred to as the "Trust Fund" (which expression shall include the said sum of Rs. 1,000/- (Rupees One Thousand) only and all other donations and contributions and evidends and interest thereon and the securities or properties, movable or immovable from time to time representing the same) upon the Trust and subject to the power, provisions, declarations and agreements here-in-after declared and contained of and concerning the same;

3. The Trust hereby created shall be known as VISHAKA EDUCATION TRUST.

4. MR. COLLINS ELAIS ALBUQUERQUE will be the administrative Officer of the said Trust and Ex-officio Trustees.

5. The Trustees shall collect, recover, receive the income, profits, interest and dividend of the Trust property and shall from and out the same pay in the first place and from time to time all proper costs, charges and expenses of and incidental to the collection thereof and all outgoings and expenses in respect of any immovable property for the time being subject to the Trusts thereof including all rents, rates, taxes, insurance and other outgoings costs of ordinary repairing and also the costs, charges and expenses of and incidental to the executions of the Trusts, power and provisions herein contained and costs, charges and expenses of the appointment from the time of new or additional Trustees or Trustee thereof.

6. After defraying the expenses stated in Clause 5 above, out of the net income and profit that may remain, the Trustees shall set from year to year such responsible sum or sum of moneys that may be decided by them for meeting the major repairs to the Trust property and net income thereof and if necessary the corpus or any part there of shall be used only for Indian Nationals and within India for all or any of the following charities, objects and purposes:


- To start and conduct pre-primary, primary and secondary schools, colleges for the spread and promotion of educations;
- To give fees, scholarships, prizes, books and other help to students of either sex irrespective of caste, creed and colour.



7. (a) The funds, property etc. belonging to or possessed of the Trust shall stand in the name of the Trust.

(b) The Trustees of the Trust shall not be less than 3 and more than 5. The first Trustees hereby appointed shall hold the office as such Trustees during their life time. If their place is not vacated for any of the reasons stated in clause -8 here-in-after mentioned.

8. Wherever any Trustee shall resign, die or become solvent or desire to be discharged from or refuse or become unit or incapable to act in the Trusts and powers in him respond under these presents or Trustee for the time being or the executor or executors of the last surviving or continuing Trustees or the retiring Trustees shall be writing appoint any other person or persons to be a Trustees or Trustees in place of the Trustees or Trustees so dying or becoming insolvent as aforesaid or refusing or becoming unit or incapable to act is aforesaid but so that the number of the Trustees shall not be less than or more than 5.

9. The Trustees of the said Trust shall have power to manage, control, conduct, undertake and take over the management of the other institution or institutions having objects of public charitable nature.

10. The Trust shall subject to the provisions here-in-after contained invest the Trust funds in any of the followings:

(1) Stock funds and securities for Central or state government or Municipal Bonds or any other securities or shares guaranteed by the Government of India or any state government.

(2) Deposits with Scheduled Banks in current, saving, fixed or call deposit fecona.

(3) Purchase of or mortgage on any immovable property in India there freehold or leasehold or any other tenure.

(4) Securities authorized by the Indian Trust Act or Securities authorized by law governing public trust for the time being in force.

(5) To borrow or raise any moneys required for the purpose of the Trust on such terms and with or without security as may be determined and to grant or direct to be premed mortgages for securiting the same.
